

Our services for child victims of sexual abuse include:

- ♦ Forensic Interviews
- ♦ Medical Exams
- ♦ Advocacy
- ♦ Counseling
- ♦ Community Education

Our referrals come directly from Law Enforcement and Social Services.

#### Care Cottage Mission

The mission of the Kentucky River Child Advocacy Center is to provide a comfortable, safe environment where children who have victims of sexual abuse and their non-offending caregivers may receive services from each agency involved in the investigation and prosecution of these cases. We strive to provide a location where investigations may be preformed in as timely manner as possible and to link children and families to services they may need both immediately and in the future.

The Care Cottage participated in many outreach programs this summer.

- ⇒ April 1st the Care Cottage joined forces with the Rising Center to color the triangle in downtown Hazard blue and teal for child abuse and sexual abuse awareness. The Mayor of Hazard also signed a proclamation at City Hall, proclaiming April Child Abuse Prevention month in Perry County.
- ⇒ April 26th we were invited to Carr Creek Elementary where we handed out information at their Superhero Special Needs Celebration night.
- ⇒ May 11th provided opportunity to participate in the Lee County Casey's Law Training where staff not only handed out information on our center, but was able to bring back some informative literature regarding Casey's Law.
- ⇒ May 30-31 The Care Cottage was invited to the Berea College Appalachian Fund Affiliates Gathering in Berea KY to present information on who the Care Cottage is and what role we play in the community, as well as make many networking connection within the community.
- ⇒ June 7th The Care Cottage returned to Lee County at the Public Library for their Summer Celebration where kids learned how to stay safe, drug free, and healthy.
- ⇒ June 16th the Perry County Fair was a hit with the Care Cottage's "Face It" curriculum on making a "SPLASH" this summer. This curriculum teaches parents how to talk to their kids about body safety using everyday materials such as their swimsuits.


and take home with them afterwards. Donations of fleece blankets can be made directly to the Care Cottage.





Stewards of Children® is a prevention training that teaches adults how to prevent, recognize, and react responsibly to child sexual abuse. The program is designed for organizations that serve youth and for individuals concerned about the safety of children.
